Mission Statement: *“The purpose of the Thompson Valley Art League is to promote an enthusiastic pursuit of art, to encourage individuality and freedom of expression, provide league members with opportunities for public recognition, and to advance to the public the knowledge, appreciation and practice of the arts, and collection of works of art.”*

Members’ meetings are the third Thursday of every other month with the first meeting in January. Guest artists, demos or programs may follow the business session. Information is communicated through the lincolngallery.com website or email. To become a new active member, artwork in one or more mediums must be juried by the board of directors. **Any membership may be reconsidered by the board at any time.**

A thirty-five percent (35%) commission will be charged on all sales in the gallery or other venues arranged by the League/Gallery, unless otherwise determined by the board.

Active Members:

- Active members have the opportunity to display on a monthly basis each medium for which they have been accepted.
- An active member retains voting and displaying privileges as long as the membership level requirements are upheld.
- **Each active member is required to volunteer at Art in the Park, as determined by the event director.**
- Each active member is required to attend three membership meetings per year, serve on one committee and participate in scheduled events during the calendar year, such as Night on the Town (NOTT).
- Members who do not meet the above requirements as of December of each year will not be eligible for renewal of membership for the following year.

Non-active Members:

- Non-active members may not display artwork on a monthly basis.
- Non-active members may enter juried TVAL art shows or participate in special events.
- Non-active members will receive the newsletter and may serve on committees.
- Membership status can be converted to Active status at any time after artwork is juried and Active membership dues are paid.
- Non-active members are encouraged to participate in activities and meetings; however, they are not eligible to vote on business matters of the League or Gallery.

Patron Members:

- Patron membership is non-voting and not directly involved in the gallery, but may show support of the organization through: Volunteer time, in-kind services or monetary donations. Monetary donations can be paid as a lump sum or quarterly and qualify as a tax deduction as allowed by IRS regulations.

All memberships shall be due and payable January 1 of each calendar year. If dues are not paid by January 31 of each new year, membership and privileges will be terminated. Reconsideration of membership will be as per the Policies and Guidelines.
